Eicher Volvo Group: Candidate claims through a relieving letter that he was associated with VE Commerical Vehicles Pvt Ltd , however the letter appears to be not authentic. As observed the letter is not a relieving letter, spelling mistakes are evident, no employee code mentioned and the candidate name does not appear in EPFO payment list of the company.

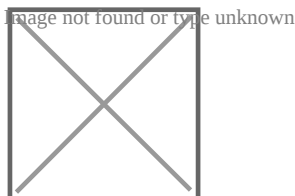
